NCWorks is North Carolina's workforce system. Both NCWorks staff and the website can help job seekers search for jobs, create resumes, and find education and training; employers can find candidates, post jobs, and search labor market information.

On-the-Job Training offsets initial training costs to fill skilled positions while building organizational productivity as new employees learn job requirements. An OJT arrangement can be the impetus for an employer to create a job opportunity. Wage reimbursement ranges from 50 to 75 percent, depending upon the size of the business, with higher percentage for businesses with up to 250 employees.

The Work Experience (WEX) program helps companies looking to grow their business and add additional, trained staff. WEX partners with companies to identify viable youth (18-24) candidates and perform pre-hiring screening. Participating youth are paid by the program for up to 29 hours per week for work in for-profit or non-profit settings (with a maximum of 240 hours in for-profit settings, 520 in non-profit settings).



The Small Business Ombudsman program at ICEDC works with small businesses to navigate regulatory requirements in the development process, including building standards, zoning, water/wastewater/sewer, and environmental quality.

#### **Backflow**

Every commercial property is required to have a functioning backflow preventer installed and inspected annually. Before signing a lease or purchasing a building, check with the respective town official or water provider to find out if the unit/ property has an up-to-date backflow preventer or what will be required to install one.
